# **IMPORTANT INFO**

All Ames and umuC kits are delivered with bacterial strains in a semisolid medium. The semisolid strains must not be repeatedly thawed and frozen. The freezing process can cause damage.

Shipping is at ambient temperature, but the strains must be stored at -70° upon arrival. Please contact Xenometrix for further information if you have a -20° freezer only. If transport at ambient temperature is longer than 10 days, then the strains must be discarded.

The S9 Cofactor kit is not included in the Ames MPF kits. It is available separately (APCO-0800).

Ames MPF Aqua kits are for the testing of aqueous Sample such as wastewater.

Ames MPF 1-sample kits correspond to 48 agar plates per strain in the traditional assay.

Ames MPF 10-sample kits correspond to 480 agar plates per strain in the traditional assay.

Shipping of the YES / YAS kits is at ambient temperature, the strains must be stored at 2-8°C (for up to 1 month) or -20°C ( > 1 month).

The experimental designs (number of does, placement of controls on the plates) may be customized according to personal needs, but only the suggested designs are supported by the calculation sheets.

Products marked "On-Demand" require minimum 4 week lead time. Please inquire.

# Mutagenicity and Genotoxicity Kits

The Ames MPF and Ames II assays are modified versions of the Ames test using liquid culture instead of agar plates. The assays are based on the fluctuation method cited in OECD Guideline 471 but use 384-well microtiter plates and have a colorimetric read-out. The great advantage of this format is the lower amount of sample needed and much easier handling. The Ames MPF assays use TA98 and/or TA100, TA1535, TA1537. All these test strains are recommended in the current, formal test guidelines.

The Ames II assay differs from the Ames MPF assays in that it comprises TA98 and TAMix, consisting of 6 histidine mutant Salmonella tester strains, TA7001-TA7006. Each of these mutants can be reverted only by a specific transition or transversion, so that all possible base-pair changes can be detected by TAMix. The TA700x tester strains are not included among the recommended tester strains in the currently formal test guidelines.

Xenometrix offers practical training and in-house testing of the Ames MPF and Ames II assays in its facilities in Allschwil.

- 1. General Unless otherwise expressly agreed in writing by a duly authorized representative of. Aniara Diagnostica, Inc. ("Aniara"), the terms and conditions contained herein constitute the entire agreement between the parties with respect to the subject matter hereof and supersede all prior communications and agreements. Acceptance by Aniara of Purchaser's order, or Purchaser's acceptance of Aniara's proposal, is expressly limited to and conditioned upon Purchaser's acceptance of these terms and conditions that may be changed or waived except in a writing signed by the parties. "Products" as used herein shall include products, parts and accessories furnished to Purchaser by Aniara.
- Delivery/Risk of Loss Unless otherwise expressly agreed in writing, the Products shall be delivered F.O.B. point
  of shipment. Aniara reserves the right to deliver in installments. Notwithstanding any agreement with respect to
